



## **Financial Statement Disclosures for December 31, 2024**

The following is the Public Trust Advisors, LLC (Fund Administrator) interpretation of your disclosure responsibilities related to your participation in the FLCLASS local government investment pools. The information provided may be required for the financial reporting of Participants in FLCLASS. Participants should consult their auditing and accounting professionals regarding their specific reporting requirements.

### **General Description**

According to the Governmental Accounting Standards Board (GASB), in order for an investment pool to qualify for the use of amortized cost accounting for financial reporting purposes, it must meet all of the criteria listed in GASB Statement No. 79. FLCLASS is managed as stable value NAV pool, while FLCLASS Enhanced Cash is managed with a floating NAV, but they do not meet all of the specific criteria outlined in GASB 79 Paragraph 4, therefore FLCLASS Participants should report their investments in the pools at fair value. The value of your investment in FLCLASS as stated on your December 31, 2024 statement should be used as the fair value of your investment.

### **GASB 72 Fair Value Hierarchy Reporting for FLCLASS**

FLCLASS measures its investments at fair value and therefore a Participant's investments in the pools are not required to be categorized within the fair value hierarchy for purposes of Paragraph 81a(2) of Statement 72\*.

### **GASB 40 Note Disclosure Requirement for FLCLASS**

#### **Credit Quality Disclosure**

FLCLASS is rated by S&P Global Ratings. The current rating is 'AAAm.'

FLCLASS Enhanced Cash is rated by FitchRatings. The current rating is 'AAAf/S1.'

#### **Custodian Credit Risk Disclosure**

FLCLASS and FLCLASS Enhanced Cash are external investment pools and therefore are not subject to custodial credit risk; your investment in the pools is exempt from the reporting requirement.

#### **Interest Rate Risk Disclosure**

The dollar weighted average days to maturity (WAM) of FLCLASS at December 31, 2024, was 46 days and the weighted average life (WAL) was 82 days. The WAM of FLCLASS Enhanced Cash at December 31, 2024, was 128 days and the WAL was 182 days.

Weighted Average Life (WAL) calculates the average number of days until maturity for a portfolio of securities using the stated maturity date for all securities, including variable rate, callable or puttable securities.
